Critical Care Consultancy (CCC) is based in Suriname, South America, and staffed by highly professional and experienced Intensive Care Unit (ICU) and Emergency Room (ER) doctors.

We offer 24/7 Rescue Mission Support, Emergency Air and Ground Medical Services. Our medical evacuation (medevac) team is directed and coached by N.A. Ramdhani, MD, an Anesthesiologist - Intensivist with European certificates, ATLS and HUET certification and hands-on experience with HEMS in the Netherlands.

Our collaboration with other domestic and foreign medical experts, training organizations and equipment suppliers allow us to offer a very broad range of services.

CCC has obtained compulsory licensing approval through the Suriname Ministry of Health (MoH) to provide offshore Advanced Life Support (ALS) and pre-hospital medical care for offshore Oil and Gas patients and transport to any hospital.

CCC also organizes and takes part in medical workshops, medical emergency and evacuation drills to increase your company's medical awareness and knowledge. The contents of these workshops can be customized to meet your company's specific needs and requests.

CCC-Medevac

The CCC-Medevac operation is staffed by ER/ICU doctors or specialists who provide 24/7 on-call Medevac, medical consultation and medical emergency response services. This is an essential difference compared to the basic HEMS staffing by a paramedic for medevac. Having an ER/ICU doctor present at the scene means that we can provide both emergency/trauma care and intensive care as soon as our team reaches the patient offshore. Professional quick response makes the lifesaving difference!

In case of a medevac, a Medevac physician and our CCC team onshore are part of the response and tiered approach to medical evacuation. CCC has an internationally protocolled best practice approach to Medevac transport based on an evaluation and assessment of the severity of each case. The CCC-Medevac team will consist of ER/ICU doctor(s) or specialist(s) customized to the medical incident.







CCC-Medevac Procedure Outline:

- The CCC on-call physician coordinates the necessary emergency medical services and directs and supports patient care from the time of the initial call until the patient is stabilized and escorted onshore to the receiving healthcare facility
- A consultation between the on-call physician and the offshore/ remote medical personnel leads to a decision regarding the level of response that is required
- An estimated time of arrival at the emergency department will be provided by the on-call physician
- The local ground transport ambulance department is contacted with the destination of the helicopter and the best estimate of time of arrival during the inbound flight
- In the case of a mass casualty scenario the on-call physician will contact the emergency department to provide their team with as many details as possible. Additional staff will be will be mobilized for a medevac if necessary
- To facilitate the quickest response time, the CCC-Medevac on-call Team will be stationed nearby the Heliport or another air carrier facility such that they can report for duty at the departure site of the air carrier within 20 minutes and maintain an ETD (Estimated Time of Departure) of 40 minutes from the time of the initial call

Professional Medical Liability

CCC maintains Professional Medical Liability (PML) Insurance for its designated crew members. Our PML comprises the use of licensed medical staff for supporting air ambulance services.

New Services

Critical Care Consultancy is continuously striving to become a single point of access for the ill or injured in need of on-site general, urgent and emergency medical care. In order to be able to offer our clients the quickest response time and smooth transition from the response site to a local health care facility we are now providing emergency ambulance services,



operating under the strict national protocols (under construction) for emergency patient transport. For patients coming in by a medevac flight this will mean the quickest response time and smoothest transition to a local tertiary health care facility, as the ambulance will home-based at the Gummels Heliport. In this way our clients will no longer be dependent on the availability of the local hospital ambulance services.

Via the established relationship with the local hospitals and clinics we will continue to work with health and emergency service partners to keep striving for more consistent and efficient medical care - benefiting all our patients. We will also continue to collaborate and consult with other national and international Medical Directors within Tele- Health for logistics and after-care.

By adding 24/7 ambulance/mobile intensive care services to our portfolio we can keep the logistics lines short to ensure proper care, in the right place, at the appropriate time.
